

THE TAKIS SPREAD THE BITE OF ZOMBIE SWEEPSTAKES
OFFICIAL RULES

MANY WILL ENTER, FEW WILL WIN. NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

The Takis Spread the Bite of Zombie Sweepstakes ("Sweepstakes") is sponsored by Barcel USA, LLC ("Sponsor"), 301 Northpoint Dr. #100, Coppell, TX 75019 and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on September 4, 2018 at 12:00 PM Eastern Time ("ET") and ends on October 31, 2018 at 11:59:59 PM ET ("Sweepstakes Period"). Administrator's computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is offered only to legal U.S. residents of the fifty (50) United States, who are at least thirteen (13) years old at the time of entry. Employees, contractors, directors, officers, and agents of Sponsor, Administrator, and each of their respective parent companies, divisions, dealers, affiliates, subsidiaries, distributors, advertising and promotional agencies and suppliers involved in the Sweepstakes ("Sweepstakes Entities"), as well as the members of each of their immediate families (spouse, parents, children, siblings, and in-laws) and persons residing in the same household as such individuals are not eligible to enter or win. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

- 3. HOW TO ENTER THE SWEEPSTAKES:** There are two (2) ways to enter the Sweepstakes:
 - A. Upload a Photo or Video to Instagram or Twitter:** During the Sweepstakes Period, an eligible entrant must have Twitter and/or Instagram downloaded on his/her smartphone or computer. An entrant must take a selfie photo or video (entrant may take a selfie photo or video showing his/her green tongue from eating Takis Zombies but is not required to) (collectively a "Photo" or "Video"). An entrant may take his/her Photo or Video on Snapchat using the Takis lens filter but is not required to (entrant may create a Snapchat account for free if he/she does not already have one). Once entrant takes a Photo/Video he/she must save the Photo/Video to his/her phone and then follow the steps below:
 - i. Sign into his/her Twitter or Instagram account (entrant may create a Twitter or Instagram account for free if he/she does not already have one);
 - ii. Become a follower of @takisusa on Twitter or Instagram (if not already following @takisusa). There is no charge to sign up for Twitter or Instagram or to follow @takisusa; and
 - iii. Compose a new Tweet or Instagram post sharing his/her Photo/Video, including the hashtag "#takisZombieBite" and #sweepstakes to receive one (1) entry into the Sweepstakes.

The content included in the Photo/Video entry will not be judged or used in any way to determine the winners. By entering the Sweepstakes and using the hashtag "#takisZombieBite" and #sweepstakes, entrant hereby agrees to be bound by these Official Rules. Photo/Video entries will be deemed made by the authorized account holder

of the Twitter or Instagram account the entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Twitter account or Instagram by the online service provider. An entrant must have a non-private Twitter account or Instagram account to enter the Sweepstakes and must be a follower of @takisusa on the platform used to enter until December 1, 2018 for potential winner notification purposes to be eligible to win/claim a prize. If an entrant does not have a non-private Twitter account, he/she can create one at no cost by visiting www.twitter.com. Please note that an entrant must agree to comply with the Twitter Terms of Service (<https://twitter.com/tos/>) and Privacy Policy (<https://twitter.com/privacy>) (if entering using Twitter) in order to participate in the Sweepstakes. Entrants may create an Instagram account at no cost by logging on to <http://instagram.com>. Creation of an Instagram account requires an entrant to agree to Instagram’s Terms of Service and Privacy Policy, available at <http://instagram.com/about/legal/terms/> and <http://instagram.com/about/legal/privacy/>, respectively. Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. If an entrant enters from his/her wireless phone, the entrant’s wireless service provider may charge the entrant. Entrants should consult their wireless-service providers regarding their pricing plans. Message and data rates may apply. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Snapchat, Twitter or Instagram.

Photo/Video Entry Requirements: All Photo/Video entries must comply with the following restrictions:

- Photo/Video entry must contain the hashtags “#takisZombieBite” and #sweepstakes
- Photo/Video entry must be an original work;
- Photo/Video entry must be in English (except for commonly understood foreign words);
- Photo/Video entry must comply with Snapchat terms of service located at <https://www.snap.com/en-US/terms/>, Twitter terms of use located at <https://twitter.com/tos/> and/or Instagram terms of use located at: <http://instagram.com/about/legal/terms/>; Entry cannot have been published previously by any party other than the Entrant;
- Photo/Video entry must be suitable for publication (i.e., may not be obscene or indecent);
- Photo/Video entry cannot contain trademarks, logos or trade dress owned by any third party, or advertise or promote any brand or product of any kind, other than the Sponsor’s;
- Photo/Video entry cannot contain copyrighted materials owned by others (including photographs, sculptures, paintings and other works of art or images);
- Photo/Video entry cannot include the name, likeness, photograph, or other indicia identifying any person, living or dead, without written permission from that person;
- Photo/Video entry cannot be sexually explicit or suggestive, violent or derogatory of any ethnic, racial, gender, religious, professional or age group;
- Photo/Video entry cannot promote illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing), any activities that may appear unsafe or dangerous, or any particular political agenda or message;
- Photo/Video entry cannot describe or depict any illegal activity or violation of any state or federal law;

- Photo/Video entries must not include any personally identifiable information (full name, e-mail address, telephone number, etc.);
- Photo/Video entries must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
 - gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - the use of prostitution, pornography, nudity, profanity or other adult content, or violence;
 - the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- Photo/Video entry must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way.

If any Photo/Video entry fails to comply with any of these Photo/Video Entry Requirements or any other provisions of these Official Rules, at the Sponsor's sole discretion, Sponsor reserves the right to disqualify the entrant.

By participating in the Sweepstakes, entrant understands that he or she is providing his or her information to Sponsor and not Snap, Inc. ("Snapchat"), Twitter, Inc. ("Twitter") or Instagram, LLC. ("Instagram"). Further, entrant specifically agrees to release Snapchat, Twitter and Instagram from any and all liability associated with this Sweepstakes. This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Snapchat, Twitter, Instagram, or any of their affiliates

B. Alternate Method of Entry: To receive two (2) entries without making a purchase and uploading a Photo/Video, an eligible entrant may visit takiszombiebiteamoe.prizelogic.com ("Website") and register for the Sweepstakes by entering the information requested on the registration form, which may include, without limitation: his/her first and last name (initials are not permitted), valid e-mail address, complete mailing address (P.O. Boxes are not permitted), date of birth, telephone number and affirmation that he/she has read and agrees to be bound by these Official Rules. Upon completion and submission of the registration form, the entrant will receive two (2) entries into the Sweepstakes.

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY IF AN ENTRANT ENTERS THIS SWEEPSTAKES ON HIS/HER MOBILE DEVICE. NOT ALL MOBILE TELEPHONE/WIRELESS PROVIDERS CARRY THE SERVICE NECESSARY TO PARTICIPATE IN THIS SWEEPSTAKES. ENTRANTS SHOULD CONSULT THEIR WIRELESS PROVIDER'S PRICING PLANS. MOBILE ENTRY IS NOT REQUIRED TO ENTER OR WIN A PRIZE IN THIS SWEEPSTAKES.

LIMIT: Regardless of method of entry, there is a limit of one (1) entry per social media platform or two (2) entries at the Website per person per day (for a total of two [2] total entries per person per day during the Sweepstakes Period. A "day" is defined as starting at 12:00 AM (midnight) ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period, except on September 4, 2018 when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET. If an entrant enters more than two (2) times per day, only the first two (2) entries for such day will be included in the Sweepstakes.

4. RANDOM DRAWING: After the conclusion of each calendar day of the Sweepstakes Period, Administrator will randomly select a total of ten (10) potential daily prize winners from all eligible entries received during each calendar day of the Sweepstakes Period for a total of five hundred eighty (580) potential daily prize winners. Non-winning entries will carry-over into subsequent daily drawings. On or about November 1, 2018, Administrator will select one (1) potential grand prize winner from all eligible entries received during the Sweepstakes Period and two (2) potential first prize winners from all eligible entries received during the Sweepstakes period. Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE, AND ODDS OF WINNING:

A. Grand Prize (1): The grand prize winner will receive two (2) \$1,500 Visa® Prepaid Cards and one (1) package of 25ct Takis Zombie Minis (“Grand Prize”). The approximate retail value (“ARV”) of the Grand Prize is \$3,010.99. Only one (1) Grand Prize will be available in the Sweepstakes.

B. First Prizes (2): Each first prize winner will receive a \$1,000 Visa Prepaid Card and one (1) package of 25ct Takis Zombie Minis (each a “First Prize”). The ARV of each First Prize is \$1,010.99. Two (2) First Prizes will be available in the Sweepstakes.

C. Daily Prizes (580 total; 10 awarded per calendar day): Each daily prize winner will receive a Takis bag, a package of 25ct Takis Zombie Minis, a Takis Zombie T-shirt (size of T-shirt decided by Sponsor in its sole discretion), a Takis baseball cap, and a Takis Zombie cup (each a “Daily Prize”). The ARV of each Daily Prize is \$22.64. Five hundred eighty (580) Daily Prizes (ten [10] per calendar day) will be available in the Sweepstakes.

D. Total ARV: The total ARV of all prizes available in this Sweepstakes is \$18,164.17.

E. Odds of Winning: The odds of winning a Daily Prize depend on the total number of entries received during each calendar day of the Sweepstakes Period. The odds of winning a Grand Prize or First Prize depend on the total number of eligible entries received during the Sweepstakes Period.

F. General: The Visa Prepaid Card is issued by the Bancorp Bank, Member FDIC, pursuant to a license from Visa U.S.A. Inc. and can be used everywhere Visa debit cards are accepted in the U.S.

In no event will more than one (1) Grand Prize, two (2) First Prizes, and five hundred eighty (580) Daily Prizes (ten [10] per day) be awarded during the Sweepstakes Period. If, for any reason, more prize notifications are sent (or more claims are received) than set forth in these Official Rules, Sponsor reserves the right to award the intended number of prizes through a random drawing from among all eligible prize claims received. No prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize, or component thereof, of equal or greater value in case of unavailability of the prize or a prize component. There is a limit of one (1) Grand Prize or one (1) First Prize, and one (1) Daily Prize per person throughout the Sweepstakes Period.

6. HOW TO CLAIM A PRIZE: Potential winners are subject to verification of eligibility and compliance with these Official Rules. The potential winners who entered online will be contacted via e-mail or telephone. The potential winners who entered via Twitter or Instagram

will be notified by a Direct Message from @takisusa on Twitter or Instagram with instructions on how to claim a prize. The potential winner must respond to the Direct Message winner notification within forty-eight (48) hours or may, at the Sponsor's sole discretion, be disqualified. The Grand Prize and First Prize winners will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release (except where prohibited) and any other requested documents within five (5) calendar days from the date of attempted notification or the prize may be forfeited in its entirety and awarded to an alternate winner, at the Sponsor's sole and absolute discretion. Failure to provide all required information and a signature on the documents within the stated time period may result in forfeiture of potential winner's right to claim his/her prize, and may result in the prize being awarded to an alternate winner, if time permits. The Sweepstakes Entities shall not be held responsible for any delays in awarding a prize for any reason. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the prize, or the winner notification is returned as undeliverable or the potential winner fails to respond to a winner notification within the timeframe specified in such winner notification, or if the potential winner does not answer the initial notification, the prize may be forfeited. If a prize is forfeited for any reason, Sponsor may, at the Sponsor's sole and absolute discretion, select an alternate potential winner at random from among the remaining pool of eligible entries received during the Sweepstakes Period, time permitting. If, after a good-faith attempt, Sponsor is unable to award or deliver a prize, the prize may not be re-awarded. Prizes will be mailed to verified winners at the address provided upon verification or entry (if entrant entered through the Website) (PO Boxes not allowed). Prizes are not transferable and include only the items specifically listed as part of the prize. Any portion of a prize not accepted by winner will be forfeited. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for the prize won. Sponsor will issue a 1099-MISC for the Grand Prize and First Prize winners. ARVs are as of the time these Official Rules were printed and the value of the prize may fluctuate. The winners are not entitled to any difference between the ARV and the actual value of the prize at the time the prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. Each prize will only be awarded to a verified winner.

LIMITATION OF LIABILITY:** By participating in this Sweepstakes, entrants agree the Sweepstakes Entities, Snapchat, Twitter, Instagram, and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers, Web masters and their respective officers, directors, employees, representatives, designees and agents ("Released Parties") are not responsible for any and all liabilities, including but not limited to lost, late, incomplete, stolen, misdirected, postage due, or undeliverable e-mail notifications or postal mail; or for any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections or availability; or garbled, corrupt or jumbled transmissions, service provider/Internet/website/UseNet accessibility, availability or traffic congestion; or any technical, mechanical, printing, or typographical or other error; or unauthorized human intervention; or inaccurate capture of Sweepstakes-related information; or the failure to capture, or loss of, any such information. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING BUT NOT LIMITED TO ATTORNEYS’ FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORTING TO ANY FORM OF CLASS ACTION.
